




Austria 2008






Different fertility rates across Europe and future population structures

Longer life in good or bad health?

- Concept of disability free life expectancy
- Based on self-perceived health, taking into consideration chronic diseases and impairments in activities of daily living
- Proportion of time spent in good health increased both for men and women
- Indicators for a compression of morbidity
- > At higher ages: Frail women and dead men



(2) Survey on Ageing in Europe



Survey of Health, Ageing and Retirement in Europe (SHARE)

- Longitudinal panel population aged 50+, living in private households
- Multidisciplinary project health, economy, social network
- Financed mainly by European Commission through the 5th and 6th Framework Programme








Partner status, Austria






Partner status by gender, Austria

Close parent-child relations across Europe

Existence of longstanding regional patterns of 'weak' and 'strong' family ties.


Many **similarities**:

In all countries 75% of parents have at least one child living at a distance of at most 25 km.

Frequent contact with children: Share of persons with less than weekly contacts to a child is equally low (7%).



Housing (ownership of dwelling)






Further aspects of housing

Size of the residence
Number of steps to the entrance
Rent payments
Owning further properties (holiday houses, land, forest)
Special features that assist persons who have physical impairments or health problems (AT: 6%, SE, NL, DK: 12-17%; strong correlation with age)

Years living in current dwelling (Least mobility: Austria, Mediterranean countries)




Residential mobility (years in current dwelling)



Self-perceived health, by age


"Less than good health"

Social engagement

- Voluntary or charity work
- > Sports or other social club
- > Help to family, friends or neighbours
- > Educational course
- > Religious organisation
- > Political organisation



Volunteering

- Volunteering is frequent in some countries:
- > Overall, 10 percent do volunteer work.
- ➤ In Scandinavia as well as in the Netherlands this percentage is even twice as high.
- In Greece, less than 4 percent report doing volunteer work.
- > Austria: 8 percent



Going to a sport, social or other kind of club

- Similar pattern
- High participation in North and Switzerland (25-33%), low in South (6%)
- > Austria in between (14%)
