

## OVERVIEW

---

Located in the Yangtze River Delta on China's eastern coastal area, Jiangsu is one of the regions in China with the most rapid economic growth and the greatest openness and vitality. With a strong industry foundation and huge market potential, Jiangsu is now an important hub of manufacturing industry in China and worldwide. In recent years, the province has witnessed the thriving of new-generation information technology, bio-medicine, new materials and a lot of other emerging industries. Its economy has been at the forefront in China with high-quality development. In 2019, the GDP of Jiangsu reached RMB 9,960 billion (about USD1,400 billion) with an annual growth of 6.1%, and the total volume of import and export surpassed RMB 4,300 billion (about USD 600 billion), both among the national top.

As a S&T powerhouse, Jiangsu is strong in regional innovation capacity. Jiangsu enterprises, active in innovation, have large demands for international technology cooperation. The province also boasts a well-developed intellectual property rights protection system and favorable policies for international cooperation. It has been engaged in extensive S&T cooperation with over 70 countries and regions, establishing co-funding mechanisms for industrial R&D with countries and regions such as Israel, Finland, Norway, the Czech Republic and Victoria of Australia, and has formed close partnerships with a large number of prestigious universities and research institutes overseas and multinational corporations. Jiangsu has become one of the most preferred choices in China for overseas R&D institutions and high-tech enterprises seeking partners for R&D and technology commercialization.

Since 2008, Ministry of Science and Technology of the People's Republic of China (MOST) and Jiangsu Provincial People's Government have successfully held six sessions of the China Jiangsu Conference for International Technology Transfer and Commercialization (CITTC), which has become one of the largest and most influential events of international innovation cooperation and exchange in China. To further promote Jiangsu's openness in innovation, the 7<sup>th</sup> CITTC will be held with the theme "Networking Online, Partnership for Innovation", in Nanjing from November 11 to November 13, 2020.
